CANDIDATE INFORMATION FOR JAMAICA PLAIN NEIGHBORHOOD COUNCIL ELECTIONS TO BE HELD SATURDAY, OCTOBER 19, 2013

<u>Eligible Residents</u> are those 16 years old or older as of the election day

AND

Listed on the most-current City of Boston List of Residents

OR

Showing proof of age, identity, and residency. Such proof includes, but is not limited to: government-issued photo ID, current school report card with envelope, drivers permit, birth certificate, a piece of mail from a utility or governmental agency, or a letter or other document attesting to residency in an area shelter such as the Shattuck Shelter at 170 Morton Street or a similar facility.


- Jamaica Plain Neighborhood Council Election packets will be available at the public libraries (Jamaica Plain, Connolly, and Egleston), and Curtis Hall beginning on August 6, 2013
- Candidates should check-off the neighborhood ("A", "B" or "C") in which they intend to run, or check off that they intend to run "At Large." If the candidate is the owner of a business or the director of a non-profit organization in Jamaica Plain, and not a resident, the Candidate must provide the name and official address of their Jamaica Plain business or organization and run in that neighborhood or At-Large. No candidate may run simultaneously in more than one neighborhood district, or for a neighborhood district and at-large seat.

Area "A" is Ward 10, Precincts, 6, 7, 8 and 9 (east of South Huntington Avenue) Ward 11, Precincts 4 and 5 Ward 19, Precinct 1

Area "B" is Ward 11, Precincts 6, 7, 8, 9 and 10 Ward 19, Precincts 4, 6, and 9 (East of Centre Street).

Area "C" is Ward 10,
Precinct 9 (west of South
Huntington Avenue)
Ward 19, Precincts 2, 3, 5, 7, 8,
9 (West of Centre Street) and 12.

At-Large is all three neighborhoods (A,B,C) of Jamaica Plain.



• To be on the ballot, candidates must:

- 1. Be 16 years or older (October 19, 2013)
- 2. Be an <u>Eligible Resident</u> of Jamaica Plain or own a business or direct a non-profit organization in Jamaica Plain (see <u>Eligible Resident</u> defined above)
- 3. Have at least 25 qualified signatures of Eligible Residents for a District candidacy or at least 50 qualified signatures of Eligible Residents for an At-Large candidacy. If a candidate's nomination signatures include names that may not be listed on the current City of Boston List of Residents, the candidate shall certify in writing that adequate proof (as described above) was provided to the candidate at the time of signature.
- 4. No later than 5 PM on Friday, September 20, 2013, candidates must have filed nomination papers (including candidate biography for publication of no more than 100 words)¹ at the

Election Dates

The election will be held on **Saturday**, **October 19**, **2013** from 10 am to 7 pm

There will be three polling places on that day:

- Forest Hills MBTA Station
- J.P. Licks
- Jackson Square Stop and Shop
- All eligible residents of Jamaica Plain (see Eligible Resident printed above) will be allowed to vote at any of the polling places.
- Ballots will be counted under the supervision of the Ombuds Board at an open and public count starting at a time determined by the Ombuds board.
- Official results will be released and certified by the Ombuds Board on Monday, Oct 21, 2013

¹ In addition to the candidate biography to be submitted at the time of nomination, all official candidates are asked to submit this bio by email to the Ombuds Board at ombuds.jpnc@gmail.com prior to September 20, 2013. These biographies will be submitted to the Jamaica Plain Gazette, Jamaica Plain Patch, and other media for publication.
